Article VII - PASTOR

B. QUALIFICATIONS AND DUTIES: Pastors must be credentialed clergy in the UFMCC. The Pastor of the church shall have the authority for ordering all worship services of the church. The Pastor is a voting member of the local church administrative body when necessary to break a tie vote. The Pastor serves in an advisory capacity as the moderator of the Board of Directors.

Motion to correct the last sentence to be: The Pastor serves in an advisory capacity as the moderator of the Board of Directors.

Article VI - Board of Directors

**F. Meetings – Regular meetings of the Board of Directors shall** be held monthly. *Except for Executive Sessions, meetings shall be open to the congregation and to the public to attend as Observers without* voice or *vote.* Voice may be granted to observers at the discretion of the meeting moderator and consent of the Board of Directors. Notice and tentative agenda of such meetings will be available to the Congregation no later than the Sunday preceding the meeting.

By-law suggestion

Article IV - Members

A. Criteria for Membership – Any baptized Christian <u>who has completed the MCC membership</u> <u>class</u> may become a Member by participating in the Rite of Membership. A Member in good standing is a Member who registers their attendance, or provides identifiable financial support, or makes a definite service contribution, or demonstrates interest and loyalty.

Motion to adopt this language and presented to the congregational meeting made by Michael Whitaker and seconded by John Larsen. Motion carries.

Building Search: Kelly McFarland. Kelly needs guidance from the BOD as to how to proceed in order to make this team successful.

Motion for the BOD to appoint Rev.
